पहला सेट जारी किया है। योजना के तहत अधोषित संपत्ति की उचित बाजार मूल्य पर योजना शुरू होने की तारीख से घोषणा करना जरूरी है। इस तारीख को आगे के किसी भी हस्तांतरण के लिए संपत्ति के अधिग्रहण की लागत माना जाएगा।

अगर काले धन के मालिक ने सिर्फ आय का एक हिस्सा ही घोषित किया है तो उस व्यक्ति को घोषित आय पर ही छूट मिलेगी और जिस आय की घोषणा नहीं की गई है उसमें कोई राहत नहीं मिलेगी।

इसमें कहा गया है कि ऐसे लोगों को अपनी समूची अधोषित आय उजागर करनी चाहिए।

वित्त मंत्रालय ने कहा है कि जिन लोगों ने भ्रष्ट गतिविधियों के जरिये धन कमाया है वे घरेलू कालाधन खुलासा योजना का फायदा नहीं उठा सकेंगे। घरेलू कालेधन की घोषणा की चार महीने की सुविधा खिड़की 1 जून से शुरू होगी।

इसमें कहा गया है कि इस योजना के तहत दी जानी वाली जानकारी गोपनीय रहेगी जैसा कि आकलनकर्ता के आयकर रिटर्न के मामले में होता है।

एक सवाल कि क्या कोई व्यक्ति भ्रष्टाचार के जरिये कमाए गए धन से अर्जित अधोषित आय का खुलासा कर सकता है, के जवाब में एफएक्यू में कहा गया है- 'नहीं'। यह योजना भ्रष्टाचार निरोधक कानून 1988 के तहत दंडनीय अपराध के किसी अभियोजन के संबंध में लागू नहीं होगी।

राजनीतिक संकट की न्यायिक जांच

शिशिर प्रशांत
देहरादून, 20 मई

उत्तराखंड कैबिनेट ने राज्य में दो महीने तक चले राजनीतिक संकट की न्यायिक जांच कराने का फैसला किया है। जांच में यह जानने की कवायद होगी कि अगर कुछ 'गलत गतिविधियां' हुई हैं, तो उनके लिए कौन जिम्मेदार है।

मुख्यमंत्री हरीश रावत की अध्यक्षता में राज्य सचिवालय में हुई बैठक के बाद मुख्य सचिव शत्रुघ्न सिंह ने कहा कि उच्च न्यायालय के सेवानिवृत्त न्यायधीश 18 मार्च से शुरू हुए राजनीतिक संकट के सभी

पहलुओं की जांच करेंगे, जो करीब दो माह तक चला। कांग्रेस के 9 विधायकों ने 18 मार्च को विद्रोह कर दिया था, जो पिछले बुधवार को भाजपा में शामिल हो गए। सिंह ने कहा, 'इस न्यायिक जांच का मुख्य मकसद यह जानना है कि इस दौरान क्या कोई गलत गतिविधि हुई है।' न्यायिक जांच कराने का फैसला उसके कुछ दिन बाद आया है, जब सीबीआई ने स्टिंग ऑपरेशन की जांच जारी रखने का फैसला किया है, जबकि राज्य सरकार ने 2 अप्रैल को केंद्रीय एजेंसी से मामले की जांच कराए जाने की अधिसूचना वापस ले ली थी।

The 56 years old Narayanan, who was posted in Philippines during the Maggi ban, is the first Indian since 1998 to head Nestle India. And since, his appointment, Maggi noodles re-entered the market in November 2015 and regained leadership position within five months.

"Sensing the environment is very important. During the past year, our engagement

with consumers has improved and teams in states have been beefed up. Today we are the only company that collects information 24x7 through multiple media," he said.

Nestle's revamped customer engagement service receives 1,200 items of feedback a day compared to seven three years ago. While the project was conceived some time ago, the fiasco speeded up the process.

The crisis, which had the potential to grow even bigger, also let Narayanan "do things which otherwise someone would not try".

"It gave us an opportunity to rethink our strategy and come back stronger. When you are in trouble you try to come up with new ideas and try new things. Some may work some may not," he said.

Refiners clear part of \$6.4-bn dues to Iran

PRESS TRUST OF INDIA
Tehran, 21 May

Ahead of Prime Minister Narendra Modi's maiden visit to Iran, Indian refiners have made first euro payments in four years to clear a part of the USD 6.4-billion in past oil dues.

Mangalore Refinery and Petrochemicals (MRPL) has paid \$500 million and Indian Oil Corp (IOC) \$250 million over the past two days, sources with direct knowledge of the

development said. Essar Oil to pay \$500 million.

The refiners cleared part their outstanding toward crude oil they buy from Iran through Union Bank of India which in turn transmitted payment to National Iranian Oil Co through HalkBank Turkey.

This is the first payment by Indian refiners in a foreign currency since lifting of sanctions against Iran in January this year.
