Once the tenders were closed, around 406 bids were received for 86 geographical areas. While Adani Gas got 11 areas through joint ventures and six single bids, IOC was successful in grabbing nine geographical areas. Those who won more than five blocks include Torrent Gas, Gail Gas and Bharat Gas Resources.

During the current round, PNGRB has kept a floor tariff of ₹30 per million metric british thermal unit (MMBTU) for city gas and ₹2 per kg for Compressed Natural Gas.

"As per provisions of the CGD Authorisation Regulations, authorisation shall be granted to successful bidders after receipt of the requisite Performance Bank Guarantee from the concerned entities," PNGRB said in a statement.

It added that the remaining areas are being evaluated and outcome of the same will be announced shortly. Out of the total 86 GAs on offer, Adani had put in the maximum number of bids of 52, out of which 20 areas were in tie up with IOC. At present, city gas network is available in 91 GAs, catering to only about 4 million piped natural gas and 3 million CNG consumers.

Through the current round of bidding, CGD volumes are expected to increase from 25 million metric standard cubic metres per day (mmscmd) to



The government on Friday gave out the 50 millionth free LPG connection, achieving the target almost eight months ahead of schedule. Speaking on the occasion, Lok Sabha Speaker Sumitra Mahajan said the scheme has not just saved eyes and money of poor women but also their "honour", as they would now not be required to venture into forests to collect firewood. She, however, wanted more of 5 kg cylinders to be given, rather than the prevalent 14.2 kg ones to help the poor buy fuel. Petroleum and Natural Gas Minister Dharmendra Pradhan said the target has been achieved in 27 months instead of 35 months. **PTI**

50 mmscmd in five years. A maximum of 15 bids were received for area including Srikakulam, Visakhapatnam and Vizianagram districts in Andhra Pradesh.

In order to maximise gas penetration and to meet the target of having 15 per cent share of gas in overall energy market, the government revised the bidding criteria during the current round by giving 80 per cent weightage to infrastructure creation, compared to 0 per cent earlier.

## DowDuPont 'defers' trials of GM corn seed

DowDuPont Inc has told India it is putting off trials needed for approval to sell a genetically modified variety of corn, taking a cue from US rival Monsanto that has also pulled a similar application due to intellectual property concerns.

In a letter addressed to India's environment ministry reviewed by Reuters, the Indian arm of DowDuPont said it had obtained permission to conduct trials growing a small crop of the corn in the northern state of Punjab but would like to "defer the undertaking".

It did not give a reason for its decision.

"This is to confirm that we

have deferred the Biosafety Research Level-I confined field trials with transgenic maize planned during the season of kharif 2018," a DowDuPont spokeswoman told Reuters in an email, referring to the summer planting season. "The company remains committed to advancing agricultural productivity in India." She declined to give details. The decision to put off trials is not public, Monsanto, now a unit of Bayer AG, in 2016 withdrew an application seeking approval for its next generation of GM cotton seeds stung by a series of unfavourable government decisions. **REUTERS**
